**Sub: Special Recruitment Drive for Reserved Category of OBC (Delhi) Candidates under Backlog Vacancies on Regular Basis for the post of Assistant Environmental Engineers (AEEs) in DPCC**

The Delhi Pollution Control Committee (DPCC) is a self-sustained autonomous body working under the administrative control of Environment Department, Govt. of NCT Delhi and exercises the delegated powers and functions of Central Pollution Control Board (CPCB) under section 4(4) of the Water Act, 1974 and section 6 of the Air Act, 1981. DPCC entrusted with the responsibility to regulate the industries and commercial establishments in Delhi as per the provisions of Air Act, 1981 and Water Act, 1974. DPCC act as a regulatory body for implementation of various Pollution Control Act Rules, Notifications, and Court orders in NCT of Delhi. DPCC does not receive any Grant in Aid from the Govt. of NCT of Delhi / Govt. of India for meeting its expenses.

2. DPCC is following the Pay & Allowance and other employee's benefits as per the 7<sup>th</sup> CPC and Orders/Guidelines issued by Govt. of NCT of Delhi and DOPT from time to time.

3. The DPCC invite applications for filling up the vacant backlog Group 'A' posts of 'Assistant Environmental Engineer' (AEE) in Level-10 (Rs 56100-177500) reserved for **OBC (Delhi)** on regular basis in accordance with RRs of the post of AEE as available on DPCC website. The reservation of posts is for OBC communities of Delhi as per the orders /guidelines issued by GNCTD and Govt. of India. The tentative details of posts are as under:

The copy of relevant valid cast certificate belonging to OBC (Delhi-NCL) is to be enclosed. A declaration must also be submitted by the candidate before appointment, affirming that he/she does not belong to Creamy Layer of OBC.

**The communities of OBC as per Delhi Government will be considered for OBC reservation even though in UPSC ESE exam, it was considered as General under the Central list.**

- The certificate must be issued by the Competent Authority of GNCTD and must have been issued on or before the submission of application by the candidate.

4. The appointment will be provisional and is subject to Certificate being verified through the proper channel and if the verification reveals that claim to belong of OBC-NCL is fake/false the services will be terminated forthwith without assigning any reasons and without prejudice to such further action as may be taken under the provision of Indian Penal Code for production of Fake/False certificate.

5. The Merit List of 'Non-Recommended Candidates of Engineering Service Examination (ESE), 2022 and 2023' as available on the UPSC website are being utilized for recruitment of above Group 'A' posts of AEEs.

**GENERAL INSTRUCTIONS:**

- i. Before submitting the application, the candidate must ensure that he/she fulfills all the eligibility criteria and other conditions mentioned in the advertisement. He/she should carefully verify the information provided in the application form, such as date of birth, categories, sub-category [OBC (NCL)], email ID, etc. before final submission, as no corrections will be allowed later.
- ii. The decision of DPCC regarding eligibility criteria, acceptance or rejection of applications, mode of selection to the post, etc., shall be final and binding on all candidates. Mere fulfillment of the minimum qualifications, experience, and job requirements will not entitle candidates to be called for interview. No correspondence will be entertained from candidates found ineligible or not called for document verification/interview.
- iii. The candidate already selected against reserved posts for OBC (Delhi) in DPCC, will not be eligible for these posts.
- iv. DPCC reserves the right to modify, alter, restrict, enlarge, or cancel the recruitment process, if necessary, without issuing any further notice or assigning any reason whatsoever. The decision of DPCC shall be final and binding, and no appeal will be entertained in this regard.
- v. DPCC will not bear any liability related to service bond, salary, leave salary, etc., from any candidate's previous employment in the Central Government, State Government, Autonomous Bodies, or Public Sector Undertakings.
